HTMA Success Affiliate Program Terms & Conditions

By joining the HTMA Success Affiliate Program, you agree to the following Terms & Conditions. Please read them carefully.

1. Eligibility & Enrollment

- You must complete and submit the Affiliate Application Form for approval.
- HTMA Success reserves the right to accept or reject any application at its discretion.
- Affiliates must be 18 years or older to participate.

2. Affiliate Links, QR Codes & Discount Codes

- Approved affiliates receive a unique affiliate URL and a QR code for tracking success referrals (as defined below*).
- Potential customers must use the affiliate's link or QR code to be tracked and for affiliates to qualify for commissions.
- Affiliates are also provided with a discount code, which gives referred customers \$200 USD off the \$3,800 USD enrollment fee.
- The discount code alone does not track successful referrals. It is solely a benefit for the customer.

*A successful referral is a customer who:

1. Enrolls using your affiliate link or QR code. This is the only way referrals are tracked.
2. Pays in full.

3. Signs and returns the required enrollment form & disclaimer.
4. Receives the welcome email and course access email.

3. Commission Structure & Payments

- Affiliates earn a \$120 USD commission per successful referral.
- Commissions are paid on a monthly basis via PayPal.
- Affiliates will receive a summary report of their sales before payment is made.
- You will be notified when a payment is being processed.
- Affiliates must provide accurate PayPal details to receive payments. HTMA Success is not responsible for failed transactions due to incorrect payment details.

4. Program Guidelines & Restrictions

To maintain program integrity, affiliates must not:

- Misrepresent HTMA Success and its program or make false claims about results.
- Use spam, misleading, or deceptive marketing practices to promote their affiliate link.
- Offer additional discounts, incentives, or cashback beyond the official program offer.
- Bid on HTMA Success or Susan Cachay branded keywords in paid ads (e.g., Google Ads, Facebook Ads).
- Share or distribute their affiliate code publicly on coupon websites, forums, or deal sites.

Violations may result in commission forfeiture and removal from the program.

5. Termination & Modification

- Affiliates may leave the program at any time by providing written notice.
